#### APPROVED CENTRE REGISTRATION FEES:

#### FEE

Registration Fee (Includes £250.00 for Initial External Quality Assurance Visit)

It is a quality assurance requirement that Centres have an External Quality Assurance visit within 3 months of being awarded FAA Approved Centre status. For Centres wishing to offer SQA Accreditation qualifications, the quality assurance visit will need to be undertaken prior to awarding any SQA Accreditation certification.

FREE OF CHARGE

The FAA quality assurance procedure alternates between on-site EQA visits and desktop audits on an annual basis. FAA will conduct an on-site EQA visit shortly after Centre registration which is included in the registration fee. A year after registration the Centre will be required to complete a desktop audit which is conducted by FAA free of charge and will then alternate between on-site EQA visits and desktop audits for the lifetime of your Centre registration.

Ad hoc EQA visits may also be required should a need be identified during routine quality assurance procedures. The Centre will be informed of the fee and reasons for the visit in advance.

Please note any visit cancelled within 14 – 28 days of the visit date will be charged at 50% of the visit fee. A visit cancelled within 14 days of the visit date will be charged at the full EQA visit fee.

#### INDEPENDENT PANEL APPEAL REVIEW

Should a Centre wish to appeal against a decision made by FAA a fee of £200 is payable upon lodging the appeal.

This fee will be refunded should the appeal be upheld.
